


Exhibit A – Territory & Location

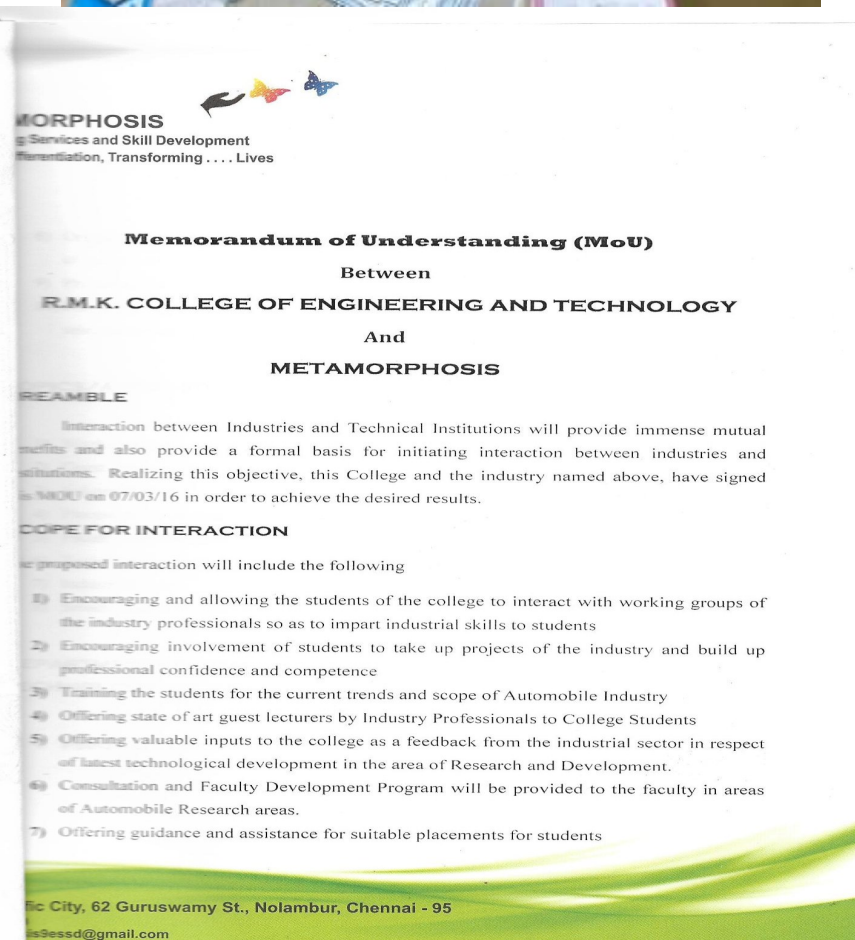
